Investigated and prosecuted affirmative fraud claims, including qui tam actions, on behalf of the United States against major pharmaceutical corporations, hospitals, and defense contractors. Representative cases:

Lampinski v. Holder: Tried and obtained complete defense verdict in jury trial of an employment discrimination case initiated by an employee of the Federal Bureau of Investigation who claimed she was demoted and denied eligibility for various lateral positions at the agency due to sex discrimination and retaliation. Of the four claims remaining at trial, the court granted the FBI's Rule 50 motion on two of the claims. The jury returned a verdict for the FBI on the remaining two claims.

Smith v. Donovan: Tried and obtained complete defense verdict in jury trial of an employment discrimination case initiated by an employee of the United States Department of Housing and Urban Development who claimed she was not promoted due to her race and sex. Also obtained summary judgment on first amendment discrimination claims.

Keating v. United States: Tried and obtained complete defense verdict in bench trial of a medical malpractice case initiated by the estate of a resident who suffered a chronic obstructive lung disease exacerbation while housed in a united states department of veterans affairs medical center, also litigated third circuit affirmance of trial verdict.

*Smith v. Donahoe*: Tried employment discrimination case initiated by a United States Postal Service employee who claimed he was discriminated against based on his disability. At the end of his cross-examination, the plaintiff agreed to settle the case for a nominal amount.

*Delrossi v. Unites States*: Arbitrated and obtained complete defense verdict in an automobile accident case where surveillance video showed the government vehicle striking the pedestrian plaintiff.

*Bridges v. Astrue*: Successfully defended three temporary restraining orders filed against the Social Security Administration by an employee Administrative Law Judge who claimed he was the victim of race discrimination. Was granted judgment in favor of the SSA following a full evidentiary hearing and briefing of all legal issues. Successfully defended the judgment on appeal before the third circuit.

Moore v. Shinseki: Argued and was granted summary judgment in favor of the VA on race discrimination and retaliation claims arising from suspension of an employee who was found to have sexually harassed his co-worker. Also litigated third circuit affirmance of the entry of summary judgment.

In re Linerboard Antitrust Litig.: Defended the Internal Revenue Service from being held in contempt, resulting in a written commendation from the presiding judge in his published opinion.

*New-Howard v. Shinseki*: Obtained summary judgment on behalf of the VA on a complex case, litigated for over a decade, involving claims for race discrimination, retaliation, and violation of the Privacy Act.

United States v. Health Management Associates: Settled \$55 million health care fraud case relating to two hospitals in Lancaster, Pennsylvania. The resolution was part of a larger \$260 million settlement between the Department of Justice and HMA that arose out of HMA's fraudulent billing practices in multiple healthcare institutions across the United States.

*United States v. Thermacore*: Settled procurement fraud False Claims Act allegations under a federal government small business innovation program for \$965,000.00.

*United States v. Temple University*: Settled overbilling case resulting in payment of \$100,000 to the United States Attorney's Office arising from claims submitted for neurology services.
